Parties are strongly advised to:

- note that UNEP/FAO/RC/COP.12/INF/18 does not reflect the views or positions of the majority of Parties to the Convention, or of the COP, and:
- ensure no formal decisions taken at RC COP-12 authorise the Secretariat or any entity to take any specific action, particularly with regard to options proposed in Section III, 62, (b), (e), and (f).
  - UNEP/FAO/RC/COP.12/INF/18 presents a range of views and proposed possible actions that lend unfortunate attention to minority views on outcomes and processes beyond the scope of the Convention or its mandate for action. Most of the very few Parties that submitted views relating to RC-11/4 have blocked Annex III listings of pesticides and industrial chemicals under the Convention, despite clear and in cases repeated recommendations for Annex III listing from the Chemical Review Committee (CRC).
